Easy-to-read and userfriendly instrument panel and ergonomic grip for better machine manoeuvrability.



On the machine rear are the controls for lifting and adjusting the scrubbing head as well as the levers for service and parking brakes. There are also two drain plugs on the recovery tank, one being larger for easier internal cleaning.

## **SUCTION MOTOR**

The suction motor is vertically positioned. In the recovery tank area there is a clear division between the suction filter and the squeegee inlet whose shape has been designed in such a way to provide cyclonic performance effect of the air-flow

## **SOLUTION TANK**

Without lifting the solution tank, the suction filter and the safety float can

be removed for their cleaning through the upper opening

### SQUEEGEE ASSEMBLY

The squeegee assembly can oscillate to follow every movement of the machine so that perfect drying is ensured. Squeegee adjustment does not require any special tool and can be performed by the operator him/herself

### **BATTERY COMPARTMENT**

The battery compartment is positioned at the centre of the machine, and it is integrated in the tank's volume.

tank's volume. All around the batteries, the plastic materials are resistant to oxidizing vapours so that any ugly and harmful rust formation is prevented.







# Convenient and quick daily maintenance helps to keep cleaning performance constant



The solution and recovery tanks, in rotational polyethylene, are very strong and are both shock and rust resistant. The solution tank is positioned in the upper part of the machine so that effective and constant water flow onto the brushes is ensured. It is filled through a large opening, and it has a holding capacity of respectively 75 liters for Omnia 26 BT and 105 liters for Omnia 32 BT.





## Stop&Go

The system for making cleaning operations more economical, optimizing consumption and reducing emissions

When the machine is temporarily idle, the solution flow is interrupted, the brushes are halted and the brush head is automatically lifted off the floor, with no need for operator intervention.

So that consumptions are optimized, and wastes reduced.

Pressing the forward movement button resets the functions that were previously activated.
